### Individuals and businesses connected to driven grouse shooting in the UK

This is not a comprehensive list of grouse moors. The individuals/companies below have been identified from information in the public domain as either:

(a) being involved in the ownership of estates where driven grouse shooting has taken place, OR

(b) participating in grouse shooting, AND

(c) having some interests or connections with the world outside grouse shooting.

It should be noted that this is not a list of estates that have been directly or indirectly involved in illegal persecution of protected species. Nevertheless, across the whole of England, no hen harriers successfully bred in 2013, and grouse moors have been their principal habitat.

More owners, and discussion of specific persecution incidents, have been identified in the Main Report too.
